## INSTRUCTIONS AND APPLICATION FOR A FLORIDA MARRIAGE LICENSE BY MAIL

1. Applicants must be 18 years of age or older to apply for a marriage license by mail.
2. A blood test is **not** required in the State of Florida. This is for non-Florida residents.
3. The fee for the license includes the statutory fee for the license, mailing charges (license is sent back to you or your Officiant after it is issued by the courthouse) and a processing fee.

This fee can be paid by money order, cashier's check or credit card. The money order or cashier's check is payable to **A Wedding For You, Inc.**

**License fee for couples living in the United States (pay by money order or check):                   \$225**  
**License fee for couples living outside the United States (pay by money order or check):           \$275**

**For fees paid by credit card, a \$5 service charge will be added to the fees.**

4. If you were previously married and the marriage ended by divorce or the death of your spouse, you must furnish the **EXACT DATE** of the divorce or the death of your spouse.
  - a. The "Information Sheet Prior to Application" and money orders for marriage license and processing fees can be mailed to A Wedding For You, Inc. at the address above. If paying by credit card, the sheet can be faxed or emailed to our office. The email address is [Karen@aweddingforyou.com](mailto:Karen@aweddingforyou.com).
  - b. The original application for a marriage license will be typed and mailed to the bride and groom. Bride and Groom are to appear before a Notary Public to swear to the information therein and to sign the original before a Notary Public.
5. The original application must to be returned to **A Wedding For You, Inc. immediately** so that the marriage license can be signed and officially issued by the Clerk of the Court.
6. The marriage license is valid for 60 days from the date it is signed (issued) by the clerk's office. Please do not submit application before 90 days prior to your wedding day.
7. Please contact us immediately if your wedding date is within 30 days of application. (Additional fees will apply.)
8. This process is not available for Florida residents.
9. After the wedding, the marriage officiant is responsible to return the license to Miami-Dade County to be recorded. You will receive a certified copy of the recorded license approximately three - four weeks after the wedding.
